Figure S1. Principal component analysis of all samples after ComBat adjustment

All samples were partitioned into the 3 groups (cell lines, primary tumors, normal samples). Each group of samples was batch-adjusted with ComBat. The three batch-adjusted groups were merged and then quantile-normalized. PCA analysis of all genes demonstrates relationships between all MERAV microarray samples.
